### Officer Elections and Transitions

#### ***For all College Panhellenic Officers***

As your College Panhellenic elects new officers, remember one of the responsibilities of the current College Panhellenic officer team on your campus is to successfully transition the incoming officers who will assume these roles. NPC has officer transition tools to help support you and your officer team do this.

When transitioning your new officers we hope you'll introduce them to these resources:

- **Update your new officers in FS Central** - Update your new officers in FS Central before the end of your term! All College Panhellenic executive board officers need to be in FS Central in order to receive communication, support and resources from NPC. You can do this by [simply sharing this form](#) with new officers and NPC will assign them a role. To learn more about officer roles, view our [quick start guide](#).
  - **Train your officers** - College Panhellenic Academy. Registration is open for the 2023 College Panhellenic Academy, Jan. 27-28. Four collegiate tracks will be offered [president, marketing/PR and two tracks for recruitment (internal and external)] as well as a fraternity/sorority advisor track.   - **Set a budget for the year** - Officer transitions are a natural time to make sure your Panhellenic budget is in line with College Panhellenic values. Use the [NPC Sample Budget](#) and example expenditures as a guide. Officer transitions are also a great time to recommit to the financial health of your Panhellenic and communicate with chapter delegates regarding any end-of-year financial items.
