#### **Recruitment Tasks This Month - March**

#### For all College Panhellenic presidents, recruitment officers and advisors

Regardless of when your campus hosts primary recruitment, there are always tasks to be completed. Refer to the Recruitment Monthly Task List for a complete list of monthly recruitment tasks.

# 7all Recruitment Campuses

#### (6 months before recruitment)

- If your College Panhellenic is considering a style shift, the ideal deadline to vote on a shift is April 1.
   Complete the Recruitment Style Assessment before proposing a shift.
- Create a recruitment counselor meeting and training schedule.

# Winter/Spring Recruitment Campuses

#### (10 months before recruitment)

- Evaluate primary recruitment using the Recruitment Success Assessment.
   Determine any necessary shifts needed for the next primary recruitment.
- Determine the recruitment counselor application and timeline and make necessary edits.

# 2023-24 Annual Reports are Due May 1

#### For College Panhellenic presidents and advisors

The College Panhellenic annual reports for 2023-24 can be found in FS Central under your Panhellenic's profile, then under "reporting," and then under "submit reports." There are four reports and they can be saved intermittently before completion as necessary. **All four reports must be complete by May 1 for award consideration.** 

College Panhellenic Annual Reports are <u>extremely helpful</u> to NPC and other College Panhellenics. Annual report responses allow NPC to provide adequate resources to your College Panhellenic and understand larger trending concerns. Please complete your annual report so we can provide the best support possible to you!
