#### For all College Panhellenic officers

We hope you had a relaxing summer break, spending time with your family and friends and gearing up for an exciting fall ahead! In preparation for the start of a new year, NPC would like to share some key reminders and information with College Panhellenics.

Changes to NPC Volunteer Support and Staff Support - Over the summer, your NPC

area advisor contact as well as your panhellenic support staff member may have changed. To verify you are connecting with the most up-to-date contact, check FS Central.



**Changes to FS Central -** FS Central received a facelift at the end of May. When you log in as a College

Panhellenic officer, you no longer see a "Search for a Group" box in the top right corner. Instead, you only see your College Panhellenic.

When you click on your College Panhellenic, you will see the functions you can use with your College Panhellenic, instead of as a sidebar. Please make sure to update contacts if you have had changes with your College Panhellenic, upload governing documents and minutes to the "Documents" tab, use the "Reporting" tab to submit NPC reports and use the "Billing" tab to pay NPC dues. You can read more about NPC dues later in this newsletter.

#### **Recruitment Tasks This Month**

### For all College Panhellenic presidents, recruitment officers and advisors

Regardless of your primary recruitment term, there are always tasks to be completed.

Refer to the Recruitment Monthly Task List for a complete list of monthly recruitment tasks.

# 7all Recruitment Campuses

(<1 month before recruitment)

- Host a Bid Day round table with chapter officers and advisors to review the day's logistics.
- Recruitment counselors contact potential new members (PNMs)

# Winter/Spring Recruitment Campuses

(4 months before recruitment)

- Confirm recruitment registration form information and questions.
- If not scheduled, host round table discussions for chapters to discuss how they will collectively market and promote the sorority

# directly for engagement, education and support.

- If applicable, meet with and get to know their PNM groups, focusing on positive Panhellenic conversations and PNM retention throughout recruitment.
- Send the PNMs a list of conversation starter questions or topics via email or group chats.
- Create a video series on leadership and sisterhood.
  - Ask chapters to participate in filmed interviews about sisterhood and leadership.
  - Have Panhellenic executive officers interview chapter leaders who can discuss various topics. Edit the interviews for short promotional videos.
- Send all registered PNMs (and their caregivers if you have the information) the MRABA explainer video along with the MRABA education document titled Preference Education: Final Preferences and the MRABA.

- Create a content calendar that includes daily storytelling, galvanizing your community to post/share, and amplifying your voice with paid ads (if your budget allows).
- Ensure the registration site has information, instructions and important details.

## **Apply Now for an Academic Excellence Programming Grant**

### For College Panhellenic presidents, programming and scholarship officers

Through a generous donation from Phi Mu Fraternity to create this fund, the NPC Foundation offers grants to College Panhellenics in support of creating a climate in which there is a constant presence and appreciation of academic excellence. We hope these grants will help you defray the cost of this programming and to be more creative in how you support academic pursuits of Panhellenic women on your campus.

Applications for grants are accepted on a rolling basis with fall (Oct. 15) and spring (May 15) review dates. After the review committee meets, applicants will be notified in June and November, respectively.

To be eligible the College Panhellenic must have paid NPC dues by Oct. 1, 2024 and have completed the most recent year's Annual Reports in FS Central.

#### NPC Annual Dues Are Now Available - Due Oct. 1

### For all College Panhellenic officers

Dues invoices were posted in FS Central at the beginning of August and are due to the NPC office by Oct. 1, 2024.

Campuses with nine or fewer chapters pay \$55 per chapter.

• Campuses with 10 or more chapters pay \$65 per chapter.
