



NPC Partner Program Overview 2025-26

The National Panhellenic Conference (NPC) Partner Program helps fulfill our mission of championing the collective interests of our member organizations and preserving the women's-only sorority experience by connecting key individuals within our 26 inter/national member organizations with businesses that work in the interfraternal space and are interested in advocating for the sorority experience.

Eligibility

You are eligible to participate in the NPC Partner Program if your company manufactures, sells, distributes or provides supplies, products or services to women's-only social sororities or their members. See Pages 3-4 for our 2025-26 NPC Partner Program benefits by level of partnership.

- Have existing business relationships with sororities?
- Want to expand the reach of your products or services in the sorority market?
- Have a product or service that can be used by individual collegiate or alumnae members, chapters or inter/national organizations?
- Work with organizations to help with fundraising initiatives?
- Have a great idea that could help advance the sorority experience?
- Want an easier way to contact organizations with nearly 400,000 undergraduate members in more than 3,300 collegiate chapters on nearly 670 college and university campuses and individual undergraduate members? Or, want to reach Alumnae Panhellenic associations, sorority alumnae chapters or individual alumnae?

If you answered "yes" to any of the questions above, becoming a NPC partner is a good fit. Please complete the partner application form no later than August 1, 2025.**

The partner year begins July 1, 2025 and concludes June 30, 2026. Throughout the year, partners, at all levels, have many opportunities to engage with member organization leaders, College Panhellenic leaders and Alumnae Panhellenic leaders. Featured opportunities include advertising to create **brand recognition/visibility**, promotion of **products/services** and **access to key decision makers**. An additional benefit of being a partner is the recognition of being an **advocate** for the sorority experience. All of the above are achieved through multiple platforms including NPC-hosted events as outlined in this document.

Advertising, Promotion and Access Opportunities

NPC Partner status includes:

- Use of the NPC partner logo on your promotional materials or website.
- Placement of your company logo on the NPC website (includes link to your website).
- Placement of your company name, logo and 50-word description in the Partner Directory shared electronically twice yearly with NPC member organization leadership and decision makers.
- Promotion of your company on NPC social media channels.*
- Recognition of your company in the NPC Update sent to NPC family.*
- Subscription to the NPC Interfraternal Inform e-newsletter.
- Opportunity to sponsor virtual and in-person events.*
- Access to a dedicated NPC leadership staff liaison*

NPC Event Opportunities

Traditionally, NPC hosts two flagship events per year: the NPC Annual Conference and College Panhellenic Academy.

The **NPC Annual Conference**, Oct. 23-25, 2025, will be held in Salt Lake City, UT. We expect 150 attendees including leaders from NPC member organizations (inter/national presidents, executive directors, delegates and chief panhellenic officers) to be in attendance. The event provides exhibit space for partners, as well as invitation to large group programming and meals for partner attendees.

College Panhellenic Academy is scheduled for Jan. 23-24, 2026 in Indianapolis, IN. Participants at this event include 275+ newly elected College Panhellenic officers and fraternity/sorority advisors from campuses across North America. The event provides exhibit space for partners.

Invitation and free registration to attend in-person events (for Bronze level and up):

- Access to attendees during NPC-hosted events: Annual Conference and College Panhellenic Academy.
- Exhibit space for partners at the Annual Conference, Oct. 23-25, 2025, and College Panhellenic Academy, Jan. 23-24, 2026. Please note that space is limited and depending on the number of partners joining, exhibit opportunities may be available on a first come basis.
- Pre-event access to NPC-hosted event attendees (via email).***
- Company logo displayed virtually on NPC-hosted event materials/signage.

We are also continuing our virtual partner updates this year—two NPC-hosted information meetings for our partners to attend and hear updates from NPC's chief executive officer about the sorority community and NPC's efforts to advocate for and support the sorority experience. The hour-long sessions will include a Q&A. Dates and times TBA.

**Opportunities vary by partner level.*

*** New this year, we are asking all partners to agree to this mutually beneficial non-disparagement language as part of the partner application process: NPC and the partners organization agrees that directors, officers, employees and agents will not make any disparaging statements or representation, either directly or indirectly, whether orally or in writing, by word or gesture, to any person whatsoever, about the other organization that is party to this agreement. This includes the directors, officers, employees, attorneys, agents or representatives of either organization, and for NPC this includes its member organizations. For purposes of this paragraph, a disparaging statement or representation is any communication which, if publicized to another, would cause or tend to cause the recipient of the communication to question the condition, integrity, competence, good character, mission, activities or quality of the person or entity to whom the communication relates.*

****In an effort to maintain data privacy for our attendees, NPC will be including opt-in language for all event registrations. All attendees who do not affirmatively consent to the sharing of their contact information will not be included on the attendee lists sent to partners. This is a change in the protocol from previous years.*

Partner Program Levels

The NPC Partner Program offers tiered levels for various access and budgets. The benefits at each level are listed in the grid on the next page. All levels are eligible for advertising, promotion, access and event opportunities. Platinum, Gold and Silver Partners are also eligible to select 2-3 (depending on level) choices from the Additional Opportunities Selection Menu.

- **Platinum \$10,000** Platinum Partners are granted the highest access to NPC member organization leadership and advertising and promotion opportunities.
 - *Platinum Plus* is a tier for organizations that have supported NPC as a member of the Partner Program at the Platinum Partner level for 5+ years. NPC is grateful for the loyal support of these organizations and recognizes the ongoing partnerships. Platinum Plus provides all benefits at the Platinum level listed below in addition to an exclusive invitation to dine with the NPC Board of Directors and staff during an annual event, as well as the opportunity to have our CEO present an NPC Update at your organization's industry event (in-person or virtual).
- **Gold \$7,500** In addition to selections from the Additional Opportunities Selection Menu, Gold Partners are invited to bring up to three attendees to the NPC Annual Conference and College Panhellenic Academy, will be promoted through multiple social media posts and emails to the NPC Family, and have a leadership staff liaison to serve as a first point of contact.
- **Silver \$5,000** Silver Partners receive social media and email promotions as well as the chance to choose two opportunities from the Additional Opportunities Selection Menu to provide an experience more tailored to the needs of the organization.
- **Bronze \$2,000** Bronze Partners are able to take advantage of NPC Event Opportunities and will receive some promotion and advertising, but are not eligible to select from the Additional Opportunities Selection Menu. This level is perfect for companies who are new to the sorority industry and want to attend the NPC Annual Conference and/or College Panhellenic Academy and make new connections with NPC leaders.
- **Friend \$750** NPC Friends receive promotional and advertising opportunities, as well as the chance to attend twice yearly NPC updates. This level is great for companies that cannot, or do not intend to, participate in in-person NPC events.
